The Sturgeon River Watershed Alliance (SRWA) is a municipally-supported watershed stewardship group that works in partnership with the North Saskatchewan Watershed Alliance (NSWA). The SRWA is guided by a Steering Committee of elected officials and a Technical Advisory Committee of staff and volunteers. Promoting knowledge transfer and sharing of BMPs.

SRWA has been able to complete an array of technical reports that address data and/or information gaps. In addition, educational communications materials have been produced for SRWA to utilize. Together these resources are readily available and are advisory. Their purpose is to provide guidance to members in order to sustain and advance watershed health and implementation of the Sturgeon River Watershed Management Plan.

Preliminary Servicing Analysis Results

The purpose of the servicing analysis is to review the adequacy of existing servicing for each defined major employment area in the Region as part of the regional growth study. The intent is to

provide a high-level analysis, relying on existing servicing plans and system capacity for water, sanitary sewer, and transportation. There are three components to the servicing analysis:

Understanding System Capacity: for each service area the development capacity for each employment area is evaluated against the growth potential and geospatial allocations to ensure that the capacity exists to accommodate future growth.

Identifying System Upgrades: where capacity constraints exist upgrades may be required to increase capacity to accommodate the planned or future growth. A high-level cost of any system upgrades will be identified.

Identifying Allocation Options and Impacts: where servicing capacity constraints exist and the cost of required upgrades is significant, alternatives to the allocations will be evaluated. This will involve the following analysis:

- o A determination as to whether alternative allocations of growth are possible without any impact to the growth potential of the Region (Feedback Loop).
- o A determination as to whether changes in the definition of the employment area(s) can result in an effective distribution of growth that avoids any required and costly service upgrades (Feedback Loop).
- o Consideration of agriculture land implications of the alternative geospatial allocations (Feedback Loop)

The geospatial analysis, accepted for information at the June task force meeting, allocated employment growth to the current major employment areas within the growth plan using low, medium, and high growth scenarios. The low, medium, and high growth scenarios are utilized for a
